## **Team profile – parish centres**

Following on from our departmental profiles in previous editions of the newsletters, we wanted to break it down further and introduce you to individual officers and teams here at the St Margaret Clitherow Centre.

This month, we are focusing on our parish centre team, who manage our 37 parish centres across the archdiocese through the Archdiocesan Parish Centres Management Company Limited (APCMC Ltd) subsidiary.

#### Their work includes, but is not limited to:

- Supporting the parish priest in the day to day management of the parish centre.
- Managing 37 parish centre managers and circa 275 staff
- Overseeing recruitment, payroll and absences of parish centre managers and staff
- Managing all contracts including waste, hygiene, pest control
- Managing repairs and investment to the centres
- Managing premises and personal license
- Managing and supporting new brands to supply goods such as beer, wine, spirits and soft drinks
- Supporting wellbeing and structured development of staff
- Managing financial and operational performance including the review of key financial performance ratios such as turnover to staff costs
- Supporting the development of parish centres with their contribution to the life of the parish, the outward facing work of parishes, and the wider community use of parish centres
- Attending quarterly APCMC board meetings

Last week we were delighted to confirm that the Charity Commission has registered the Archdiocese of Liverpool (the "CIO") (charity number 1199714) and so the CIO is now alive! You can see details on the Charity Commission website by clicking <a href="https://example.com/here">here</a>.

The transfer of the assets of the current trust is still scheduled to take place at the end of December 2022 so that the CIO is ready to be operational on 1 January 2023. This date has been chosen to match with our accounting year and also to give us time to transfer everything over, including property and staff.

This is a great milestone to achieve to have the CIO successfully created and standing ready for the transition.

## Days of prayer for Ukraine

**Wednesday 24 August** is Ukraine's Independence Day, to mark this, Fr Taras and Bishop Tom Neylon will lead an ecumenical prayer service at 3pm at the Cathedral. We are hoping to have a live link to Bishop Gregory Komar at Drohobych Cathedral during the service.

On Wednesday 14 September, the Council of the Bishops' Conferences of

Europe has proposed a day of prayer across Europe for Ukraine and the Council has asked that cathedrals and other major churches host a period of Eucharistic adoration.

In response, the Metropolitan Cathedral will be having a period of exposition from 4pm-5pm that day and then Mass for peace in Ukraine will be celebrated at 5pm.

## Important information for all SVP volunteers

Due to some recent confusion, we wanted to remind SVP members about the process for DBS applications.

As our parish SVP groups are affiliated with the Archdiocese of Liverpool they **must** follow the DBS processes of the archdiocese, safer recruitment processes such as references and volunteer agreements will be completed by the SVP national office or the local conference representative.

All volunteers must undergo a DBS application or DBS recheck with the safeguarding section in order to volunteer with SVP groups within the boundaries of the Archdiocese of Liverpool, these applications can be facilitated by the local parish safeguarding representative as normal.

If volunteers do not complete the process with the Archdiocese of Liverpool safeguarding section and undergo a DBS application or DBS recheck via SVP national office using Ucheck they will still be required to undergo a DBS application or recheck via the safeguarding section at the Archdiocese of Liverpool in order to take up role with parish groups.

The Archdiocese of Liverpool have worked closely with SVP national office and their safeguarding lead Catherine Kerr for many years and the process for SVP applications has not changed. If this procedure is not followed correctly, then you may not be allowed to take up role with any parish groups until an application is processed via the Archdiocese of Liverpool.

We would like to make you aware there are no reasons why DBS applications would not be processed as soon as we receive them, and applications do not need to be sent to SVP national office rather than the safeguarding section of the Archdiocese of Liverpool. When an application is completed by the applicant, countersigned by the archdiocese and sent to DBS, the application can take anywhere between 1 day and 3 months to complete, this timescale is the same for ALL organisations sending applications to the Disclosure & Barring Service.


